#### How to Enter;

1. To be eligible, participants must attend the raceday and participate in person on;

2. The football toss component of the competition commences on 18<sup>th</sup> May 2024 at 10:00am AEST and concludes on 18<sup>th</sup> May at 1:00pm AEST.

#### Rules of Play;

Entrants will have **two chances** to score a goal by throwing a football through the ball toss board from three (3) metres away. Entrants must throw the ball with their hands only, either one-handed or two-handed. Kicking or bouncing the ball is considered ineligible, or throwing the ball from less than the required distance is deemed ineligible.

Players who are successful with at least one of their throws will be required to provide their full name, email address, and phone number to be eligible to go into a random draw which will decide the final two players to advance to the Football Cannon stage.

#### 3. Prize pool consists of;

### **Stage 2 – Football Toss Random Draw**

All entrants who were successful with the football toss during the competition period (10am-12:30pm) and provided their personal details will be entered into the Random Draw.

Two (2) entrants will be selected by way of a random number generator from this pool of winners and contacted via phone on the day. Should a chosen finalist be uncontactable or not on course upon a BRC representative phoning and texting on the day, a redraw will take place to select an alternate finalist.

#### **GAME TWO: FOOTBALL CANNON**

##### **How to Enter;**

1. To be eligible, participants will have to have been successful in scoring at least (1) goal in GAME ONE and chosen as one of our two finalists by a random number generator draw.

##### **2. Rules of Play;**

The two entrants will be required to attempt to catch a football shot into the air via a Football Cannon. One (1) player at a time will compete in a "Best-of-Three" style match. The Player who successfully catches the most will be deemed the winner of the \$10,000 CASH prize.
