TERMS AND CONDITIONS

Ladbrokes Cox Plate \$5,000 CASH DASH Competition

GAME ONE: PLATE TOSS

How to Enter;

To be eligible, participants must attend the Raceday on;

Saturday 26th October 2024, Ladbrokes Cox Plate Raceday, - and meet at the Warm Up Bar (Gate 4 main entry) Doomben Racecourse.

Participants must then scan the QR code to sign up for BRC communications before beginning their attempt to partake in the competition.

The Brisbane Racing Club and Ladbrokes, Board, Management Committee, Management, Staff and their families are ineligible to enter into the promotion.

By participating in the **Ladbrokes Cox Plate \$5,000 CASH DASH Competition**, participants guarantee that he/she/they have the authority to accept and unconditionally accept the below terms and conditions.

The plate toss component of the competition commences on Saturday 26th October 2024 at 10:00am AEST and concludes on 26th October at 12:30pm AEST.

Rules of Play;

GAME ONE – PLATE TOSS

Entrants will have **two chances** to score a goal by tossing a plate through the plate toss board from at least two (2) metres away. Entrants must toss the plate with their hands only, either one-handed or two-handed. Kicking the plate is considered ineligible or tossing the plate from less than the required distance is deemed ineligible.

Players who are considered successful, are those who were able to get at least one toss of the plate through the plate toss board. and provided their full name, email address, and phone number to be eligible to go into the random draw which will decide the final two players to advance to GAME TWO.

GAME ONE Total Prize Pool consists of;

(a) One hundred (100) Raceday General Admission tickets to Canadian Club Melbourne Cup Raceday on 5th November 2024. Two tickets will be awarded to the first fifty participants who successfully toss a plate during the GAME ONE Plate Toss.

Ticket prizes will be sent to the winners nominated email address prior to Melbourne Cup Day.

One* entry only into GAME ONE is permitted per person (*one entry = 2 plate toss attempts)

Entrants' success will be determined by the BRC and/or Ladbrokes representatives witnessing the attempt.

PLATE TOSS RANDOM DRAW

All entrants who were successful with the GAME ONE plate toss during the competition period (10am-12:30pm) and provided their personal details will be entered into a Random Draw.

Four (4) entrants will be selected by way of a random number generator from this pool of winners and contacted via phone on the day at approximately 1pm. Should a chosen finalist be uncontactable or not on course upon a BRC representative phoning and texting on the day, a redraw will take place to select an alternate finalist.

GAME TWO: CASH DASH – RELAY RACE

How to Enter;

To be eligible, participants must have been successful in scoring at least (1) goal in GAME ONE and chosen as one of our four finalists by a random number generator draw.

Rules of Play;

The four finalists will be selected and randomly divided into two teams of two for a relay race. One player in each team will be positioned at the start line, the other player in the team will be positioned at the halfway point. The winning team of this relay round will then move on to race each other in the final CASH DASH race for the \$5,000 cash prize.

Players will be required to attempt to race along a 45-metre path with a wad of cash** balanced on a plate. If the wad of cash is dropped, the player must stop and pick it up before proceeding. If a player continues the race without picking up the wad of cash that dropped, they will be required to go back to the start.

The team with the player that crosses the finish line first in the relay will be deemed the winning team who will face each other in THE FINAL race.

The player who crosses the finish line first in THE FINAL CASH DASH race will be deemed the winner of the \$5,000 CASH prize.

The path and finish line will be clearly marked on the public lawn at Doomben Racecourse. Any player who goes outside of the path will be disqualified. The finish line will be monitored by BRC staff to determine the winner.

Stage Two – THE FINAL Race

The second stage of **GAME TWO** will take place on the **Doomben public lawn** between **racers 4 and 5** on the day. The two finalists are required to meet with a BRC representative before proceeding onto the competition path.
