

Christmas Hamper Competition

Description

How to Enter

All tickets from the on-sale date (Monday 9th September 2024) until 4:00pm AEST on Friday 20th December will be considered valid for entry. All valid BRC member card swipes prior to 1pm on Saturday 21st December 2024 will also be eligible for entry.

The following persons are ineligible to enter the Competition:

- a) employees, directors, officers, management, contractors and other representatives of the Promoters, and organisations involved in, or sponsoring, or conducting the Competition;
